The final payment for the 2014–15 financial year is on 25 June 2015. The amount that is accrued following this date will be paid to the employees on 2 July 2015 and be included in the 2015–16 payment summary. Withholding on the whole amount will be at the rates that apply for the 2015–16 financial year.

Version 2016.06 introduced the ability to adjust the amounts and payment types reported on the PAYG payment summaries. Once a payment to an employee has been generated via a dividend, through the pay employee wages function, or via an ad-hoc payment, the amounts being reported on the payment summaries can be adjusted in the cashbook payment entry.

### **Manually adjusting PAYG amounts reported on payment summaries**

If you've already submitted your EMPDUPE file and need to make a correction, you can use a manual payment summary form to submit the updated information. You'll need to make sure you put an x in the box for the option stating that you are amending a payment summary statement.
